We GRANT permission for the use of contestant's & all accompanying individuals' names, pictures, videos, etc. taken during the event for any promotional materials, publications, or use on social media. We GIVE emergency personnel, hospital, & the physicians on the medical staff of the hospital, permission to administer NECESSARY emergency treatment for injuries contestant may incur while participating. We hereby release emergency personnel, hospital, physicians on the medical staff, & the production team from all liability.
