**Practice Participant Release And Indemnification Agreement**

\_\_\_\_\_, hereinafter referred to as "Participant", is executing this document voluntarily or, if participant is a minor, has his/her, hereinafter referred to as "his", Parent or Guardian's, hereinafter referred to as "Guardian", express permission to participate in a sporting event on the North Texas State Fairgrounds. Participant/ Guardian states that participant has consideration of him/her being allowed to participate and/or practice he/she agrees as follows:

1. PARTICIPANT/GUARDIAN AGREES TO INDEMNIFY AND HOLD NORTH TEXAS STATE FAIR ASSOCIATION, INC., hereinafter referred to as "FAIR", THEIR OFFICERS, DIRECTORS, EMPLOYEES, MEMBERS, AND VOLUNTEERS AND/OR AGENTS HARMLESS AGAINST ALL CLAIMS, DEMANDS, DAMAGES, COSTS AND EXPENSES, including reasonable attorney's fees for the defense thereof, arising from Participants', or his/her guests', or children's activities on or around the North Texas State Fair Association Grounds, hereinafter referred to as "Fair Grounds", at any time, EVEN IF the claim, demand, damage, cost or expense is CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OR GROSS NEGLIGENCE OF THE FAIR.
2. PARTICIPANT/GUARDIAN FURTHER RELEASES THE FAIR FROM ALL LIABILITY. THE FAIR may otherwise owe to Participant, his heirs, survivors, beneficiaries, or assigns FOR ANY PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH, that Participant suffers while on the Fair Grounds, at any time, including but not limited to first aid, treatment or service rendered participant during participation in any event and/ or practice. This release applies to all injuries or damages which may be suffered by Participant, his heirs, survivors, beneficiaries, or assigns, EVEN IF CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OR GROSS NEGLIGENCE OF THE FAIR. This liability release also applies to claims and causes of action for injury to or the death of any of Participant's children.
3. PARTICIPANT/GUARDIAN ACKNOWLEDGES THAT ALL ACTIVITIES, PRACTICE OR SPORTING EVENTS, ON PROPERTY SUCH AS THE FAIR GROUNDS CAN RESULT IN INJURY or property damage to the person engaged in those activities as well as others. The many possibilities and sources of injury or damage are acknowledged by Participant/Guardian and Participant comes upon the Fair Grounds will full knowledge of such hazards. Participant/Guardian hereby gives his/her permission and consent to be transported to a hospital and given treatment by any doctor or hospital and his/her or its personnel.
4. Participant/Guardian has read this document and understands its terms and conditions. Participant/ Guardian is signing it freely and voluntarily. Participant/Guardian also releases any photographic image or video image to be used by the Fair as advertising or in promotion of the Fair and other events concerning the North Texas State Fair and Rodeo.
